

Adult Participant Release & Waiver of Liability and Indemnity Agreement

PLEASE READ CAREFULLY. THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS AND IS LEGALLY BINDING.

Assumption of Risk

I acknowledge and agree that any use of YMCA Camp Ralph S. Mason, Inc. facilities, services, equipment and premises ("Facilities") and any participation in YMCA Camp Ralph S. Mason, Inc. programs and activities ("Programs") comes with inherent risks including, but in no way limited to: (1) moderate and severe personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease including, without limitation, COVID-19 and any of its' variants. I voluntarily accept and assume full responsibility for these risks as well as any and all other risks of the use of Facilities and participation in Programs. I agree that I have full knowledge of the nature and extent of all such risks.

Participant Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of the use of Facilities and participation in Programs, I agree that YMCA Camp Ralph S. Mason, Inc., its officers, directors, agents, employees, volunteers, insurers and representatives ("Releasees") will not be liable for any personal injury, property damage, disability, death, sickness or disease incurred by myself, my family members, dependents, or guests, including minors, however occurring including, but not limited to the negligence of Releasees. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, disability, death, sickness or disease sustained from the use of Facilities and participation in Programs.

I further agree, on behalf of myself and any and all legal successors and proxies, to release and **HEREBY DO RELEASE, WAIVE AND COVENANT NOT TO SUE** Releasees from any causes of action, claims, suits, liabilities or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I and any and all legal successors and proxies may have, now or in the future, against Releasees on account of personal injury, property damage, disability, death, sickness, diseases or accident of any kind, arising out of or in any way related to the use of Facilities or participation in Programs, whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In further consideration of the use of Facilities and participation in Programs, I agree to **INDEMNIFY AND HOLD HARMLESS** Releasees from any and all causes of action, claims, demands, losses, suits, liabilities or costs of any nature whatsoever, including claims of negligence, arising out of or in any way related to the use of Facilities and participation in Programs by myself, my family members, dependents or guests, including any minors.

Minor Participant Waiver, Release, Indemnification & Covenant Not to Sue (If Applicable)

In consideration of any named minor's participation in YMCA Camp Ralph S. Mason, I, the undersigned parent/guardian of the named minor(s), agree to **INDEMNIFY AND HOLD HARMLESS** Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's participation and **HEREBY RELEASE** Releasees of all liability for such loss, damage, or death. I further certify that the named minor(s) is in good health and has no conditions or impairments which would preclude his/her safe participation in YMCA Camp Ralph S. Mason.

I further certify that I am of lawful age (18 years or older) and otherwise legally competent to sign this agreement, and that I have legal capacity to act as the parent/guardian of the named minor(s). I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will.

Family Camp Weekend Policies

(All policies are subject to change at YMCA Camp Mason's discretion.
You will be informed of any changes prior to your camp.)

To ensure the happiness and safety of all Family Camp guests, and the protection of Camp Mason property, every visitor must be aware of, and adhere to, all Camp Mason policies and procedures.

Parking is allowed ONLY in the main parking lots. DO NOT park in any of the villages. You may unload your luggage at your cabin, but you must return your car to one of the parking lots. The roads and cabin entrances must be accessible in the event of a medical, fire, or maintenance emergency.

Fires are permitted ONLY in the PRE-CONSTRUCTED campfire rings in each village, as indicated with signage. An adequate supply of firewood has been allotted to each village so please ration firewood accordingly. Do not leave campfires unattended. Please do not burn trash, glass or plastic.

Smoking inside any of the camp buildings is prohibited. Please dispose of butts in trash cans, not on the ground as they are not biodegradable. The use of illegal drugs is not permitted on camp property.

Cooking inside any of the camp buildings is prohibited unless you are staying in Spruce Lodge.

Garbage and food items must stay inside your cabin or be placed in a trash can. Please remember to shut doors and turn off lights when you are not in your cabin. This helps conserve energy and keep costs down for everyone.

Dining Hall procedures are as follows: Please arrive at the Dining Hall at the beginning of the meal. Food will be served for the first 30 minutes of the meal. After the meal, it is required that someone from your family group disposes of trash, returns dishes, and wipes down the table.

OFF LIMITS areas are only open during scheduled time periods under the supervision of Camp Mason personnel. These areas may include: the fenced-in pool area, Skate Park, directly behind the dining hall, all climbing elements/obstacle course and Lake Mason boating docks.

Pets are not allowed on the YMCA Camp Mason property due to allergy and safety concerns.

Quiet Hours are 10:00 PM - 7:00 AM. Please respect nearby families by keeping noise to a minimum at these times.

Adult supervision must be provided for all children and is the responsibility of each individual family.

Respect of camp procedures, Camp Mason employees, property, and all visiting participants must be upheld at all times. This includes giving undivided attention during announcements, understanding our schedule is flexible and subject to change, sharing camp resources, and accepting that all visitors deserve an equally enjoyable experience.

IMPORTANT: The signer of this document is responsible for communicating the above policies to all attending members in their party to ensure compliance. By checking the Acknowledgement Box on the online registration, you and your party agree to comply with YMCA Camp Mason policies and procedures. Violation of the rules may result in immediate dismissal from the Camp Mason property without a refund, and loss of cabin reservations for future weekends.
